- 1) We have reviewed the unaudited financial results of M/s. The Statutory Auditors had carried out the limited review of the financial results for the quarter ended 30th June 2017 under Regulation 33 of SEBI (Listing Obligation & Disclosure Requirements) Regulation, 2015.
- b. The Company has for the first time adopted Ind AS beginning from April 1, 2017 with a transition date of April 1, 2016. The statement has been prepared in accordance with the Companies (Indian Accounting Standard) Rules, 2015 (Ind AS) prescribed under section 133 of Companies Act, 2013 and othe recognised accounting practices and policies to the extent applicable.
- c. The IND AS compliant financial results pertaining to the relevant previous period have not been subject to the Limited Review. However, the Company's Management has exercised necessary due diligence to ensure that the financial results for the comparative period provide a true and fair view of its affairs
- d. The Company does not have significant deferred tax Liability /Asset and accordingly it will be accrued at the end of the year.
- e. The reconciliation of net profit/loss for the quarter ended 30th June, 2016 in accordance with Indian GAAP to total comprehensive income in accordance with Ind AS is given below:
