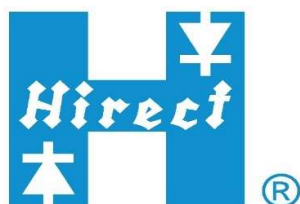

Subject: Hind Rectifiers Limited - Communication on Tax Deduction at Source (TDS) on Dividend

We hope this E-mail finds you safe and in good health.

The members of the Company at the 67th Annual General Meeting held on July 29, 2025, approved a dividend of Rs. 2.00/- per equity share of face value Rs. 2/- each for the financial year 2024-25. The said dividend is payable to those shareholders whose names appeared in the Register of Members of the Company, and the list of beneficial owners furnished by National Securities Depository Limited and Central Depository Services (India) Limited as at the close of business hours on Tuesday, July 22, 2025.

No tax will be deducted on payment of dividend to the resident individual shareholder if the dividend, paid during financial year ('FY') 2025-26, does not exceed INR 10,000/-.

The withholding tax rate would vary depending on the residential status, category of the shareholder and is subject to provision of requisite declarations/documents to the Company.

In case PAN is not updated with the Company's RTA or depository; or PAN is not available; and information sought in the declaration are not provided, higher rate of withholding tax as per section 206AA shall be applied.

The dividend as per the details given below has been directly credited to your bank account on the basis of the information registered by you with your depository participant or the Company. You are requested to please verify the credit in your bank account.

Form 16A downloaded ONLY from TRACES are considered as valid TDS certificates, as per CBDT circular 04/2013 dated April 17, 2013.

If your Bank is not able to resolve the issue, please write to Adroit Corporate Services Private Limited our Registrar & Transfer Agent (RTA), along with a confirmation from your bank that the said credit instruction was not received by the concerned Bank.

Note: In case investors held shares on the record date for dividend in multiple demat accounts or folios then PAN was clubbed for the calculation of TDS amount and TDS amount deducted proportionally to the holding in respect of individual demat account or folio no.
